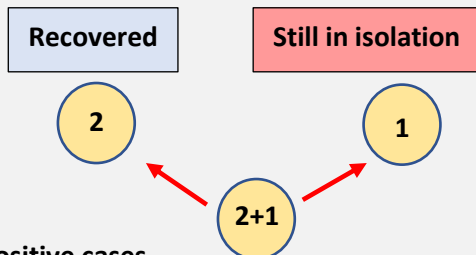

- ✓ Only classes that had direct contact with the staff member is at risk.

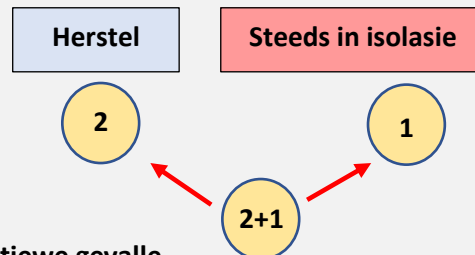
3. Actions taken:

- ✓ Reported to the Circuit Manager
- ✓ Reported to the District Director
- ✓ Reported to the NICD
- ✓ Reported to the Department of Health
- ✓ Psycho-social support provided by the school
- ✓ Learners who had direct contact with the teacher will self-isolate for 10 days and return on Thursday 3 September if they have no symptoms.
- ✓ Parents were contacted individually and informed about learners who were in close contact.
- ✓ Classes were disinfected immediately, even though it was done yesterday afternoon as part of the normal procedure.

- ✓ Aangemeld by die Distriksdirekteur
- ✓ Aangemeld by die NIOS (NICD)
- ✓ Aangemeld by die Departement van Gesondheid
- ✓ Psigososiale ondersteuning wat deur die skool voorsien word
- ✓ Leerders wat direkte kontak met die onderwyser gehad het, sal hulself vir 10 dae self-isoleer en keer op Donderdag 3 September terug as hulle geen simptome het nie
- ✓ Ouers is individueel gekontak en ingelig oor leerders wat in noue kontak was.
- ✓ Klasse was onmiddellik ontsmet, selfs al was dit gistermiddag gedoen as deel van die normale prosedure.
